**August 15th** – Notification of acceptance & Invitations will be sent to accepted vendors. **August 25th** – All payments are DUE from accepted applicants. Please note: Invited vendors are not confirmed for show unless payment is received.

Acceptance is by invitation only. All applications are reviewed by a selection committee, taking various factors into consideration in order to create a high quality, attractive show having a good mix of artistic and crafting creations. There will be a limited number of exhibitions for each category or media.

\*Please Note: Preference will be given to items that are "Hand-Crafted" vs. "Retail/Manufactured".

How is it different from others' work?* 

Items not included for submission during selection process may not be allowed in show. The Office of Cultural Arts reserves all rights to reject specific items from display.

**FEES:** \$150.00 for each 10' by 10' booth. Limited Number. There will be a \$10 fee per table if sponsor of event is asked to provide tables for booth. The Christmas Connection is Free Admission to the public. Please note: You will only be asked for payment if you are selected to be in the 2025 show, and will be notified via email.

**EXHIBITIONS:** The selection committee reserves the right to reject specific items. There will be a limited number of exhibitions for each category or media. A Christmas theme is recommended for each exhibit. *\*Please Note: Preference will be given to items that are "Hand-Crafted" vs. "Retail/Manufactured".* 

**EQUIPMENT:** If requested, two chairs can be provided per booth by sponsor of event. There will be a <u>\$10</u> fee per table if sponsor of event is asked to provide tables for booth. [specify on application]

Exhibitor will provide their own display equipment. Please, NO tall booth barriers (over 6' tall, that are solid, non-see-thru material.) Line of sight must be kept throughout the show. Taller pipe and drape, wood or metal hanging systems, etc are allowed, ONLY IF of a lightweight and translucent fabric, or wall that can be seen thru and visually appealing from both sides.

Electrical outlets are available, but limited and not guaranteed.

PARKING: Adequate parking adjacent to the building

 Each artist is responsible for paying his/her portion of applicable TN sales tax. All financial transactions and taxes are the sole responsibility of the exhibitor (information will be provided).

- o Artists may exhibit only in the medium(s) in which he/she was accepted.
- o Exhibitors must remain open for business for entire show, no early breakdowns.
- o It is the exhibitor's responsibility to have the display staffed at all times.
- Please plan for sufficient inventory.
- o Cars must be moved from loading zones once loads are complete.
- The number of light bulbs allowed will be limited due to circuit overloads.
- o All excess materials, cartons and tables must be concealed or removed.
- Alcoholic beverages are prohibited, no smoking, service animals only.
- Damage to the facility is the responsibility of the exhibitor.
- No propane gas, spray paint or hazardous materials are permitted.
